~Something for Everyone – Room for All~

Coming out of the early Sunday morning reflection group one morning I asked one of the participants if they were going to come to church, meaning for me – the church service at 10:30. The person responded "I was just at my church". That put me to thinking – church is indeed something different for everyone.

There are people who would call going to church as being part of the Friendship Group. Many don't come on Sunday morning, but the companionship and support of this group of women is their church.

Gathering over a hot cup of coffee, out of the cold, with others to talk to is church for many of our downtown folks on a Sunday morning at Linger Lunch in the gym.

Wednesday Worship is going to church for a number of people, some who aren't connected with St. Andrew's in any other way, but like to find the quiet centre of our chapel.

Then there are hundreds who come through our church doors to the St. Andrew's Concert Hall as it is sometimes called – to enjoy and be inspired by beautiful music and song.

Going to church for our Special Olympian friends would be having their dances at St. Andrew's and playing floor hockey in the gym. Then they often show up on Sunday to help clean up after Linger Lunch at their church.

Thinking it over I concluded that there are many different congregations within this place, with *something for everyone* and *room for all*.

And how do we find *room for all?* Sometimes it is a juggling act fitting people into the right rooms, and there are often times when every room is full with groups of one kind or another. Special Olympics folks might be playing games in the gym, while the Friendship Group is having a pot luck in the Club Room and a self-help group is meeting across the hall. Meanwhile there could be meetings going on upstairs. When Near North Voices show up the sanctuary is turned into a concert hall for one hundred choristers and musicians to entertain a full house of music lovers. We are fortunate to have a building that presents a venue for so many activities, not only for our congregation, but for the community at large.

I'm happy that I was part of that defining moment back in 1951 at St. Andrew's when they turned the sod for the addition to the original building and made a dream come true that there would be *room for all* and *something for everyone* right here in the heart of North Bay – our church home –St. Andrew's.



The St. Andrew's website is designed to be a site that offers general and current information about our Church community. With the posting of the TOGETHER bulletin each week on the "notice board" page, anyone can tune into the "pulse" of St. Andrew's and know what is happening. Those who are "church shopping" and regularly attending folk appreciate this kind of timely connection. (http://www.standrews-northbay.ca/notice.htm)

ADDRESS CHANGE: The internet hosting arrangements for our site were initially made through a local provider here in North Bay. Unfortunately he passed away rather suddenly in December, 2013, and the server details (including site passwords) went with him. The easiest way to solve the problem was to re-establish the site directly with a new webhost, with a new name that was similar to the old one: www.standrews-northbay.ca. Needless to say, all passwords and site information are now on file with the Church office to make sure that no further continuity problems occur.

SITE ACTIVITY:



The above "webalizer" website analysis graph records *unique visitors*, *number of visits*, *pages*, *hits* and *bandwidth* (in that order) for each month in 2014. Although actual numbers are not included, it is apparent that the relative traffic on the website has increased over the year, with the number of visits (2n^d bar in each set) peaking in September at 575. These statistics include non-human visits (worms, spybots etc.), but approximately half the "hits" are reported to be non-robotic in nature... and therefore hopefully human!

UPCOMING CHANGES: Early in 2015, plans are being made to provide a special donation page on the website. This feature will allow any visitor to make a credit card donation that will be handled by a third party organization called "Canada Helps". The cost to us will be less than 4% and will include the service of providing instant income tax receipts by e-mail. It is envisioned that this mode of giving will appeal to those who wish to donate (memorial, special projects, etc.) but are not part of the regular congregational PAR or envelope program.

A SNAPSHOT OF ST. ANDREW'S

SUNDAY WORSHIP

Central to our life together as a community of faith is our Sunday morning worship service at 10:30 a.m. when we gather in the spirit of God's love and grace.

KID FRIENDLY SPACE

We have a special space for young children who may not want to go to the nursery or church school during the service. At the back of the sanctuary there is a small table and chairs with books paper and crayons to keep the young ones occupied.

CHURCH SCHOOL

Children are an integral part of our Sunday worship. After the "children's time" with the minister and congregation, children are invited to Church School, where they use the One Room Sunday School Curriculum, supplemented with other resources.

NURSERY

A nursery is provided during Sunday worship for those requiring this service for infants to age four.

PRAYERS OF THE PEOPLE

Each week during Sunday Worship, lay members of the congregation present "Prayers of the People". As well as the traditional style, these prayers have been sung, presented as poetry, closed with a native blessing, offered in a Jewish style, etc. They are always from the heart and move us deeply into the presence of our God.

LINGER LUNCH

Twice a month after worship we have Linger Lunch, a light lunch prepared by various families/groups within the congregation. This is a wonderful time for our church family and our downtown neighbours in need to gather informally, sharing each other's joys and sorrows.

CHOIR

The Choir, under the direction of Ralph Johnston, provides musical leadership. Using a variety of musical styles, they convey the message in a manner that touches the very core of our being. They are a close-knit, fun-loving group who welcome new members.

MUSICIANS

Musicians in the congregation occasionally help with our Sunday service music.

REFLECTION GROUP

At 9:00 each Sunday morning an enthusiastic group meets to discuss various books on theology or spirituality. The topics may be challenging and controversial, but by respecting varying points of view we find our faith is deepened and our understanding of God broadened.

TOGETHER

Each week the "Together" newsletter is published to keep us informed of events within the church and the broader community. It also provides inspirational stories, prayers and daily devotions.

SUNDAY FORUMS

Occasionally after Linger Lunch, forums are held to present or discuss issues of concern within the community, the church or society. With a spirit of love and respect, we attempt to honour differences and to live the gospel.

WEDNESDAY NOON WORSHIP

Each Wednesday at noon everyone is invited to a half-hour worship service in the Chapel. Joys and concerns are shared in prayer and love within this smaller, more intimate community. Also bring your bag lunch and stay for lunch in the parlour after the service.

INTERGENERATIONAL WORSHIP

Several Sunday Intergenerational Worship Services are planned each year when the congregation as a whole experiences new and creative ways of hearing and seeing "the message" that are clear to all ages.

CHRISTMAS PAGEANT, PALM SUNDAY PAGEANT

Each year we are amazed at the talent within the congregation when people write, direct, and act in these pageants that tell the Christmas and Easter stories in new and creative ways.

CONCERTS

Our sanctuary offers a beautiful setting for local choirs and instrumental groups to perform their annual concerts. Visiting choirs from as far away as Czechoslovakia have also performed in the St. Andrew's Concert Hall.

FRIENDSHIP GROUP

The third Thursday of each month, the Friendship Group invites all women to meet in the parlour to enjoy interesting speakers, crafts, a time of devotion and the most wonderful potluck suppers. They support not only each other but also many activities in the church.

MANITOU WOMEN'S RETREAT

Every other year in October women in Manitou Conference are invited to Camp Norland for a retreat to nourish body and soul.

YOUTH CONFIRMATION RETREAT

The youth from St. Andrew's and Omond share a Friday evening and Saturday retreat in preparation for confirmation or to explore more deeply what it means to be Christian.

CHURCH PICNIC

The church school year ends with a church picnic on the lawn. Games, watermelon, and hot dogs are enjoyed by children and adults alike.

ADULT STUDY GROUPS

Two members of our congregation, Margaret Reid and Tim Robertson, facilitate adult study groups on a variety of topics, usually twice a year for nine to twelve week sessions. Modern liberal understanding of religious topics can open scriptures to people in new and relevant ways.

FAITH RENEWAL AND MEMBERSHIP INQUIRY SERIES

This six-week program is designed to prepare people for confirmation, or reaffirmation of faith, or simply to examine various aspects of the Christian faith.

LENTEN REFLECTION BOOKLET

Each year members from the congregation and others with ties to St. Andrew's write a reflection on the lectionary passage for each day during Lent. These are compiled into a booklet for use as a devotional resource during Lent.

TURKEYFEST

The best turkey supper in town takes place at St. Andrew's in November. It is amazing how much fun peeling potatoes or washing dishes can be when working with the hundreds of volunteers who help make this event a successful fund-raiser and a time of camaraderie.

SPECIAL MEALS

Depending upon who takes the initiative, other special meals such as the Harvest Dinner or St. Patrick's Supper are held to support various activities within the church and provide fellowship.

POT LUCK SUPPERS, CABARETS, GAMES NIGHTS

The annual Maundy Thursday potluck supper and communion hosted by Omond and St. Andrew's is our version of the Last Supper. Cabaret evenings provide an opportunity to visit with friends, feast on decadent desserts, enjoy a variety of musical entertainment and a hymn sing. Games Nights are held occasionally when we get together over board games, scrabble, a variety of card games and testing our skills at crokinole.

RAINBOW POTLUCKS

The congregation hosts regular potluck social gatherings for LGBT members of the congregation and their allies. Watch the Together newssheet and the church website for dates and times.

FALL AND SPRING TEAS AND BAZAAR

Many groups and individuals pool their talents and energy to make these annual teas and bazaar a success. Thank you to the UCW for starting this tradition many years ago.

KIDS ONLY BAZAAR

Children aged 4 - 13 years from all across North Bay know that this is the place to do your Christmas shopping all by yourself on a child's budget, and then relax with some Christmas cookies. Parents are not allowed in the gym, but can enjoy coffee in a separate room. Hundreds of items are donated and dozens of volunteers make this a truly unique event.

VISITATION AND PASTORAL COUNSELLING

The Pastoral Care Committee and the ministerial team visit those in nursing homes or the hospital, or those confined to their homes. The minister provides pastoral counseling.

GARDENERS OF EDEN

This green thumb gang ensures that the lawns and flower gardens reflect the welcoming, caring atmosphere for which St. Andrew's is known. They plant, weed, water, cut and generally take care of the flowerbeds and lawns.

ST. ANDREW'S GOES GREEN VEGGIE GARDEN

Meant to be an invitation for others to use public spaces in creative and sustainable ways, St. Andrew's vegetable garden, tended by our Outreach Committee, provides produce for the Gathering Place Soup Kitchen.

CHURCH MICE

Quietly and unobtrusively these church mice work behind the scenes to make our worship experience meaningful. They plan and prepare the worship space, decorate the sanctuary, and setup for communion.

SERVICES AT CASSELLHOLME AND MARINA POINT

Regular services are held at Cassellholme and Marina Point, on a rotational basis with other churches.

LOAVES AND FISHES FOOD SHARING PROGRAM

We are grateful for partnerships with corporate and charitable sponsors that allow us to provide food to over 100 people each Thursday morning. We try to remember the direction Jesus gave to "feed the hungry" and long for the arrival of his kingdom with abundance for all.

MISSION AND SERVICE FUND

By contributing to the United Church Mission and Service fund, we reach beyond our doors and our local community to support ministries throughout Canada and the world.

CHURCH COUNCIL AND COMMITTEES



ACCESSIBILITY AT ST. ANDREW'S

"I was a stranger and you welcomed me..." (Matthew 25:35)

In fulfilling our mission, St. Andrew's United Church is committed to include people with disabilities as full and active participants.

The role of the Accessibility Committee is to monitor how effectively St. Andrew's meets the



compliance requirements of the provincial *Accessibility for Ontarians with Disabilities Act* (AODA).

Currently, the only requirements in effect are those dealing with Customer Service accessibility. This committee drew up and implemented a Customer Service Policy in 2011 (see website: http://www.standrews-northbay.ca/access.htm). This policy contains a statement of St. Andrew's commitment to providing accessible services:

In fulfilling our mission, St. Andrew's United Church is committed to include people with disabilities as full and active participants. We will remove barriers and attitudes that exclude people with disabilities from full and active participation. All people are encouraged to practice their faith and use their gifts in worship, service, study and leadership.

Some features that are in place to help us fulfil our commitment include:

- lift facility serving three levels (basement, Narthex & sanctuary)
- hearing assist devices
- orders of service that have large print for the visually impaired
- ramp accessibility at the Algonquin entrance



An accessible church implies accessible toilet facilities – and it was clear that our church did not have such amenities. In 2013, the Committee began the process to convert an existing washroom into a fully accessible one. Council approval was received – and tenders were sought. Donations were received from the congregation – and the Memorial Committee offered to cover the major part of the cost in order to insure that the project was completed. We now have a barrier-free, family-friendly washroom facility located in the narthex.

I am grateful to fellow Committee member, Glenn Tunnock, for his expertise in overseeing the washroom renovation project, for his knowledge of proper process, and for his skillful navigation of bureaucratic barriers.

The next part of the AODA legislation will involve accessible employment and communication components, as well as accessibility of the built environment (actual building structure). The Committee will continue to monitor these legislative requirements and how they will affect St. Andrew's. The Committee will also be sensitive to any feedback (especially from those who are taking advantage of accessibility-related modifications) that might be received in respect to how our Church can better serve the needs of all users of the St. Andrew's building.

Jane and Tracy are primarily responsible for our pastoral care, but they spend a number of hours each week on administration tasks. Thanks to each of you for all you do.

Volunteers are also important part of keeping the church going. A special thanks to Bruce Fleming who assembles the *Together* newssheet every week and to our webmaster Derek Stott, who makes sure that our website is kept up to date. AGM Report 2014

Four Initiatives under the Christian Development Committee

The Sunday Morning Reflection Group started in 1998. The first thing the group read was a United Church of Canada study guide called *Reconciling and Making New*. Originally the group was called the Sunday Morning Bible Study Group, but we changed the name because we were reading a variety of books covering different theological understandings and faith perspectives by authors like Marcus Borg, John Shelby Spong, Henri Nouwen, Walter Brueggeman, Mary Jo Leddy, Joan Chittister, Greta Vosper, and Joyce Rupp. Last year, 2014, we started or finished three different books: *A Time to Live: Seven Steps to Creative Aging* by Robert Raines; *A Year of Biblical Womanhood* by Rachel Held Evans; and *Zealot* by Reza Asian. If you like to read—and talk about what you have read—please join us on Sunday mornings at 9 a.m. in the Parlour!

The Living the Questions Study Group went on sabbatical at the end of the

Winter/Spring 2014 sessions. What was the last study that we did? *The Apocalypse*. The end was, indeed, nigh!

The Pema Group is a Buddhist book study group that meets in the Parlour on the first and third Fridays of the month. Last year the group started or finished three different books: *Zen Mind, Beginner's Mind* by Shunryu Suzuki; *True Love* by Thich Nhat Hanh; and *The Buddha Walks into a Bar* by Lodro Rinzler. We also watched several movies like *One Particle of Dust; The Life of the Buddha; Tibet: A Trilogy;* and *Zen,* a bio-pic about medieval Japanese Zen Master Dogen. The Saturday Morning Meditation Group meets every Saturday morning for a one-hour sitting meditation from 11 a.m. to 12 p.m. in the Parlour. We gather at 10:45 so that we are ready to start promptly when the bell is rung. This is an eclectic group with members at all levels of experience (from raw beginners to multi-decade practitioners) and from very different meditation backgrounds (Tibetan and Zen Buddhist, Hindu, Christian, secular), so there is room for everyone to be enfolded in our practice. Instructional videos and audio CDs on Buddhist understandings and teachings are frequently offered before the sitting meditation from 9 a.m. to 10:45 a.m. In 2014, we did several series including: *Coming Closer to Ourselves: Making Everything the Path of Awakening* by Pema Chodron; *Fully Alive: A Retreat with Pema Chodron on Living Beautifully with Uncertainty and Change; The Power of Myth* with Joseph Campbell; *The inner Art of Meditation* by Jack Kornfield; and *How to Meditate with Pema Chodron: A Practical Guide to Making Friends with Your Mind.* If you have an interest in contemplative and meditational practices, please join us whenever you are able. All are welcome!

Building Use Committee Report - 2014

St Andrew's has an active church life with many groups and activities that make use of our space, including Bible study groups, Meditation groups, the Choir, the Friendship Group, the Loaves and Fishes Food Bank, Fundraising events, Church Council and various committees.

St Andrew's is a downtown church and we encourage the community to come and use our facilities. We have opened the building to a wide variety of groups that pay rent based on a fair rental policy. There are several choirs that regularly practice and perform here including the North Bay Choral Society, the Baytones (Ladies Barbershoppers), Gateway Harmony (hens Barbershoppers), The Rapport Singers, and the Near North Voices. In 2014 we also had singing performances by Raymond Gauthier/Jennifer Krabbe and an organ recital by Leo Ravensbergen from Holland.

The building is also used by a number of social agencies and self-help groups and others hosting private functions. We also encourage events that promote a healthy environment. Transition Town meets monthly and the annual Seed Exchange and Eco-Fair has become very popular. We advocate for our environment and several groups meet here to promote that including Energy East and Nipissing Environmental Watch.

Our church is well used, but we have room for more. Last year the rental of the church brought in \$6,613.00. We hope to bring in more revenue next year through additional rentals plus a review of our existing policies. Contact the Church office at 705-472-7680 for information about using the space.

At one of the best Transition Town/Outreach monthly potlucks in the past year we learned about torrefaction. Our passionate speaker explained that it is an initial process involved in the combustion of biomass in which all of the volatile gases are burned off, leaving only a hard, energy-rich, substance that has many uses.

Our potlucks were uneven, but sometimes they also burst into flame, spawning useful ideas and even concrete actions rather than producing just so much hot air. At the risk of sounding too serious, we focused on sustainability and living with respect in creation. And on the food and company, which was always good.

We reached out of St. Andrew's to bring lots of people down to the Club Room in support of Transition Town and other groups. There were always lots of different people in attendance, sometimes with small children, always with their own interesting stories to tell, warming up cold winter evenings.

Sometimes in the past year ideas suddenly caught fire, like the coming together at the last possible moment of people to put together the Seed Exchange and Ecofair again at our church. It is too soon to say how the event will turn out as I write this, but it is satisfying to realize that the organizing heft for this year's event will be provided by people who attended, or presented at, previous similar events at our church. We are a home of sorts to them.

We also sponsored the Integrity and Politics choir, which is lead by Ralph Johnston, and sings music composed by him to shed more light than heat

The Seed Exchange and Ecofair shows us in coldest February that spring is possible, and will come. Members of, and people associated with, the Outreach Committee also worked in what also seems improbable at this time of year, our Loaves and Fishes vegetable garden. Aside from the great pole bean misunderstanding, our garden was a good one, both in terms of process and result. It produced lots of fresh produce for the Gathering Place soup kitchen, and engaged lots of people.

Property Report 2014

As I file this report I'd like to thank all those who helped me in learning the administrative part of this position.

The first thing that I dealt with was a frozen sewer main at the front of the church (Algonquin). I was informed that the pipe was looked at and a steamer from Sturgeon Falls was called in by Golde Plumbing a few weeks prior. I took it upon myself to call the city public works to put a camera down the pipe to get a clearer picture of what was causing the backup. Due to the fact we have no cleanout traps on the Algonquin St. side, I had to bring in Golde Plumbing to remove the toilet bowl so that a camera could be put down. The camera revealed that the pipe was almost completely frozen at the sidewalk on the Cassells entrance. At that time I was also informed that the sewer main it flowed into was a dead end line and as such is prone to freezing due to standing waste water. The city's supervisor said not to hesitate to call him anytime we had an issue. Due to the same type of winter we are experiencing this year, I called Mr. Garlic at public works just prior to the concert in January and asked if he would flush the line as a precautionary measure, which he did.

The second major sewer problem occurred at Turkeyfest when the grease and drippings from the cooked turkeys were dumped down the toilets which caused the sewer to become plugged and again Golde Plumbing needed to be called in to unstop the toilet after solidified grease was removed and I attempted to unstop it myself. At this time I would like to suggest that in the future, any drippings or grease be put into pails and disposed of that way, thus, reducing plumbing costs.

We have had two new additions to our church interior the first being a new barrier free washroom at the front entrance of the church. At this time I would like to recognize and thank the members of the Memorial Committee and the congregation for making this project possible. The second project was the installation of a commercial humidifier in the sanctuary. This project was initiated by Ralph Johnston who brought to council the proposal for a proper humidifier with all specs and prices for the installation of this unit which would benefit the operation of the organ and help ensure proper humidification thus avoiding various problems low humidity causes. The value of the organ is approximately \$250,000. At this time I would like to thank Ralph, the Planned Gift Fund Committee, as well as members of the congregation, for making this a permanent solution to what was a constant problem.

On the subject of the organ, I would like to inform you of our new contract with Orgues S. Brisson Pipe Organs of Embrun Ontario for the repair and maintenance of the organ.

This concludes my report for 2014.

The St. Andrew's tradition of placing Christmas poinsettias and Easter spring flowers in the sanctuary in memory of loved ones, with the option to direct the funds to other memorial projects continues. This plan resulted in a total of \$1,520.00 in donations; \$1,321.46 for Memorial projects and \$198.54 to create attractive floral displays for Easter and Christmas. For many years Raymond Gauthier and Lois Carey have taken on the task of choosing, arranging and looking after the flowers in these two seasons.

In March 2014 we were happy to finance the acquisition of an Automated External Defibrillator (AED) from St. John's Ambulance at a cost of \$2,234.00. Glenn Tunnock steered the process through arranging a demonstration for Council, obtaining a quote for the item, placing the order, picking up the item and looking into training of operators. It would be nice if we never had to use this item, however, if we were faced with a person in crisis, we would be very thankful that we had acquired an AED.

In 2014 the Memorial Fund contributed \$7,680.55 towards the Barrier Free Washroom project in the narthex. Derek Stott and Glenn Tunnock of the Accessibility Committee obtained quotes for this project and the project was completed by Northern Classic Contracting and ready for use in September. We thank Glenn and Derek for their work as key contacts for St. Andrew's with the contractor.

Thank you to Kim Robinson, our in-house calligrapher, who prints the names in the Memorial Book to be found in the narthex. We are also grateful for the volunteer services of Jack Aiton who does repairs when required to the outside lighting and continues to look for the best way of keeping that Memorial item operational. The lights were installed in 1997, just one of the many projects that we have been able to complete through donations to the Memorial Fund.

For 110 years St. Andrew's members have gathered to worship in this building at the heart of North Bay. We have celebrated events in people's lives from birth till the end of their days. We know that the church is more than the building, but we on the Memorial Committee have a mandate to maintain this heritage building to pass on to future generations of worshippers.

Your Worship Committee meets monthly to look ahead and plan upcoming worship. It's an interesting fun committee, where we toss around ideas and broad themes for upcoming services and work out the practical details, everything from decorating to setting up communion to dealing with humidifiers.

It was a busy year – there's always something interesting going on in worship at St. Andrew's. We occasionally gave Jane a break and had in guest speakers -- Jim and Donna Sinclair for Transfiguration Sunday, Elizabeth Frazer in May, and Beth Hewson (an Anglican intern) in October. All were wonderful and thoughtful.

Palm Sunday took a break from our usual combined Palm/Passion Sunday service, which starts with the Palm Sunday celebrations and moves to the Passion of Good Friday, and this year was all Palm Sunday with a wonderful Readers' Theatre exploring that eventful day.

Each year we discuss whether it's time to let go of our annual tradition of having the sanctuary in dimness, with the windows all curtained off, to echo the darkness of the tomb on Easter morning -- and then have the curtains come down and the light pour in, and the trumpet and organ pour out the introduction to "Jesus Christ is Risen Today" – and this year, as so many others, we decided it was still too wonderful a moment to not go with it.

The Sunday after Easter was "Holy Humour Sunday" with jokes and laughter to celebrate the resurrection, and an egg cracked open over your loyal music director's head by Tracy that poured out a shower of glitter... rather than the expected gooey white and yolk!

In May we celebrated our first anniversary of becoming an Affirming Ministry – a process that has brought many wonderful gifts to St. Andrew's – with a fun "I Am Unique Because ..." project where congregation members were photographed holding up signs proclaiming their particular uniqueness. It was fascinating and fun!

For Pentecost we celebrated Jane Howe's 30th anniversary of her ordination. For First Nation's Sunday in June the sermon time was a powerful video of Will Kunder talking about the Truth and Reconciliation Committee for the Residential Schools, and amazing footage from it. We were honoured to have the Northern Kwe Spirit Drum Group join us as well.

After a low key summer, we got back into the swing of things with our Rally-Back Sunday, where EVERYONE got to go to Sunday School! Everyone got to choose one of four Sunday School classes to join in on, following the theme of Joseph and his Multi-coloured coat. What to choose? Go to a movie? Make a desert scene with sand, etc.? Make food in the kitchen? It was really neat to see what amazing stuff goes on under Tracy's capable hands when the youth go down to Sunday School.

December brought us our Christmas Pageant a modern retelling where Jesus is born to two high school students, in a cardboard box in a back alley – to Mary and Janine, rather than the more traditional Mary and Joseph.

Then it was on to our Candlelight Music and Lessons service, and the early and late Christmas Eve services. Interestingly, we are the only Protestant church in North Bay that still has a "midnight" Christmas Eve Service – and while every year it takes a little more energy to stay up so late, it's still a wonderful magical time that keeps making it worth the effort it takes to put it on. The sanctuary is never so beautiful as by candlelight while singing Silent Night, with the gorgeous dark wood soaring up into the darkness, and the evergreen wreaths decorating the balcony and the walls.

We are the keepers of the treasury. We are the watchdogs of the committees of St Andrew's as they spend their budgets. We authorize the paying of the staff and the myriad of bills that are incurred in the care and maintenance of this building. Each month we meet to authorize the payments and to discuss the life of this congregation from a financial perspective. We serve to give advice to committees as they use the budgeted amounts to carry out their mandates.

I encourage you to look at the financial statements that follow this report. The positive balance from 2013 was applied to the Building Restoration Fund. We know that there will always be a need for this money to repair the roof or floors or buttresses.

We ended up 2014 with a deficit on the year of \$14,160. This was a combination of the cold winter which ran a fuel bill of \$5,000 more than the previous year and a reduction in general offerings.

On the positive side I wish to point out that while sufficient funds may not have landed on the offering plate, the contribution from the members of the congregation in terms of dedicated hours and effort cannot be overlooked. The Fundraising Committee, the Turkeyfest people and the House Tour volunteers gave so generously of their time, sweat, and financial contributions. The people who came out to help with the teas, and the Kid's Bazaar have given much to this community.

We are always looking for additional members for our committee. So if you have an interest in the monetary world and have a couple of hours a month to share, we would love to have you join us.





THE CENTENNIAL STAINED GLASS WINDOW over the narthex was dedicated November 21st, 1982. The window was designed to be a symbol leading us into our one hundredth anniversary year, 1984. Following are remarks about the window by the artist who created it, David Morgan of South River.

"The design of the St. Andrew's Centennial window is based upon some of the symbolism within The Book of Revelation ... some of the symbols contained and easy to identify are - the four apostles, the winged man, the winged ox, the eagle and the winged lion (Matthew, Luke, John and Mark), Alpha and Omega, seven flames (for seven churches), the sea of glass, the sun and moon and stars, the Dove, Pax, the jeweled throne, and the rainbow.

There is no one way to view or read the design. However, beginning with the base of the bottom panels moving up through the center of the design we find the sea of glass (center), Alpha and Omega which echoes again larger than before above and around this (repetitious). Above this and at the center is the symbol of Christ. Next, the jeweled throne above which is the Dove (the Holy Spirit). The jeweled throne is surrounded by a rainbow and from this center a radiating light, like a beacon, shines to all corners of the design (the universe) outshining even the Sun and Moon and Stars all around it. At the sides of the design, as supporters or observers of the revelation, yet an integral part of it all, are the four evangelists as symbolic beasts.

One might argue that these symbols are all out of context and in terms of the written gospel they are. I feel, though, that collected together in this form they are a valid interpretation of the essence of the Book of Revelation, not the heavy foreboding apocalypse as many interpret it, hut a beautiful collective dream of the future so shining and beautifully complex that it holds one's interest without end."
