# Conversation with **Diane Matheson-Jimenez**

Diane Matheson-Jimenez apologized for not being able to be at this meeting in person. Diane is a CSRC Minister, Community of Support and part of her job is to support Communities of Faith through processes and conflict.

- Diane has been tasked with working with St. Andrew's Council following a challenging meeting June. There are some big issues we are dealing with and some left the meeting with hurt feelings.
- Diane suggested that we plan some visioning time together in the fall at a neutral location. Council meetings may not provide the right environment to explore some of the issues we are dealing with. A time for some robust conversation would be advantageous. This will be a time to explore what God is calling us to be and to ensure that we are working towards a common vision with a foundation of trust. Perhaps we could meet for 5 to 6 hours and share lunch together. In order to find a suitable date Karen Gooch will send out a Doodle Poll to Council members.
- We are living in challenging times and we are not the only Community of Faith facing difficult issues. Often there is a spectrum of feelings and opinions that get in the way of working together. The hope is that during this retreat time we can reflect on our Touchstones and think about the words we are using, as words said in the heat of the moment can be very damaging.

- Doug McCausland requested a chance to speak to Council members about the June Council meeting. He stated that he supports the work of Loaves & Fishes and is not against the homeless people who may be lingering around our property. However, he does get phone calls from members of the congregation about this and he felt like he was expressing their concern and may have used the wrong words. He said he felt the intention of his words was not clear to some. There is a lot of concern about the security of our church.
- In response, people were reminded that it is important to keep healthy boundaries. We also need to resist the urge to judge others for their opinions. People may have different understandings of what our mission is but as Council members we should be setting a unified example for the whole congregation. We should also remember that the church community extends beyond our walls. The focus needs to be on what we can do to improve a difficult situation by looking at practical and spiritual solutions.
- Compassion and empathy are required with the goal of treating all with dignity. At the last meeting some felt a lack of respect at times. Someone shared a story about one of their relatives and pointed out that you cannot paint everyone with the same brush. The hope is that we can recognize God in everyone.
- Diane affirmed that we are doing some good work and she is looking forward to working with us to explore how we can be better. We should remember a variation of the golden rule where we work to establish relationships to help put ourselves in someone else's shoes.

#### **Business Arising**

Walsh Bequest

The Property Committee has been tasked with determining how best to spent the \$15,000 bequest received from the Walsh family in the spring. The family's intent is that the money be spent on the building (not the belfry). There is a suggestion that the money be used to refurnish the chapel in order to make better use of the space. There is no formal plan yet. Jean Jameison and Kim Delarosbel have volunteered to be part of a sub-committee to work on this project, with the Property Committee having a consultative role. It was suggested that we consult with Brenda Walsh once we have a plan in place.

Security Contact A brief discussion was held about how to address concerns from the congregation regarding vulnerable people who may be lingering on church property. People should be encouraged to contact Janet Ross in the Office if they feel there is a security issue. This is something she would be comfortable with. Perhaps we should have a back-up plan for when the Office is closed. It should be noted that anyone can call the police is they feel there is imminent danger and people should not engage themselves in a dangerous situation.

#### **New Business**

Financial Report Appendix I

The following financial information was offered.

- Month-end Statement A statement dated June 30<sup>th</sup>, 2024 (Appendix I) was presented by Finance Committee Chair, Lorie Fairburn showing total revenue of \$167,954 and expenses of \$145,826 for a surplus of \$22,128. Lorie stated that our finances are ok for now, but offerings have been down a bit in the past month. Support for M&S is good this year with about \$8,700 being donated so far towards our \$12,000 goal for 2024.
- <u>Letter</u> A package will be sent out to the congregation with a personal statement of current donations and a letter from Caitlin Smithers reminding people of the need for their continued financial support over the summer months.

All written committee reports were emailed to Council members ahead of this meeting for review.

Administration –Derek Stott offered the following.

- Jan Ross will make arrangements with a shredding service during August.
   Anyone who has old church related documents in their possession should contact Jan about dropping them off at the church.
- The Office will be closed the 3<sup>rd</sup> week of August when Jan is on holidays. <u>Facility</u> – Bill Ingwersen offered the following in addition to the written report found in Appendix II.
- A form has been prepared for maintenance requests which anybody can use if they spot an issue that needs attention. - It was suggested that the Office should be contacted when scheduling outside contractors who are coming to do work so that conflicts with church events can be minimized, recognizing that this may not always be possible.
- <u>Spiritual Life</u> Elizabeth Brownlee provided a written report (Appendix III) with information from the Worship Team, Congregational Life/Fundraising and the Pastoral Care Team. Thanks was offered to Liz for keeping us informed of upcoming events.

Living Our Mission – Derek Stott highlighted the following.

- <u>Communications</u> The last newsletter of the summer will be released on July 26<sup>th</sup>.
- <u>Inclusivity Committee</u> The Committee will meet in August to firm up plans to coincide with North Bay's September pride celebrations September 11-15.
- <u>Loaves & Fishes</u> Lorie Fairburn provided a written Loaves & Fishes report for May (Appendix IV). This is the last week for our summer student, Robert Turk

who stated that he learned a lot from the experience. MP Anthony Rota visited Loaves & Fishes due to the fact that we received money from the Canada Summer Jobs program to pay Robert's salary.
